Qualification for the posts of Chairperson and Members of Child Welfare Committees (CWCs)

- 1. The Chairperson and Members of the Child Welfare Committee shall be above the age of 35 years on or before on the last date of the submission of the application.
- 2. The Chairperson and Member shall have a minimum of seven years of experience of working with children in the field of education, health or welfare activities, or should be practicing professional with a degree in child psychology or psychiatry or social work or sociology or human development or in the field of law or a retired judicial officer.
- 3. No person shall be eligible for selection as a Chairperson and a member of the Child Welfare Committees if;
- (i) has any past record of violation of human rights or child rights;
- (ii) has been convicted of an offence involving moral turpitude, and such conviction has not been reversed or has not been granted full pardon in respect of such offence;
- (iii) has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government:

- (iv) has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.
- 4. A member of the Committee shall be eligible for appointment of maximum of two terms, which shall not be continuous.

Qualification for the post of Social Worker Member, Juvenile Justice Boards.

- 5. The social worker member shall not be less than 35 year of age on or before on the last date of the submission of the application.
- 6. The Social Worker member shall have at least seven year of experience of working with children in the field of education, health or should be a practicing professional with a degree in child psychology or psychiatry or Sociology or in the field of law.
- 7. No person shall be eligible for selection as a Chairman or Member of the Board, if he-
 - (i) has any past record of violation of human rights or child rights;
 - (ii) has been convicted of an offence involving moral turpitude, and such conviction
 has not been reversed or has not been granted full pardon in respect of such
 offence;
 - (iii) has been removed or dismissed from service of the Central Government or a State Government or an undertaking or corporation owned or controlled by the Central Government or a State Government;
 - (iv) has ever indulged in child abuse or employment of child labour or any other violation of human rights or immoral act.
 - 4. A member of the Juvenile Justice Board shall be eligible for appointment of maximum of two terms, which shall not be continuous.
