(The tenure of the non-official Members of the Committee shall be three years from the date of notification).

Function of the Committees

- The above Inspection Committee shall visit to all facilities housing children in the area allocated, at least once in three months in a team of not less than three members, of whom at least one shall be a woman and one shall be a medical officer.

- The Committee shall also make suggestions for improvement and development of the institution.
- The Committee may visit the institutions either by prior intimation or make a surprise visit.
- The Committee shall interact with the children during the visits to the institution, to determine their well-being and uninhibited feedback
- The follow-up action on the findings and suggestion of the children shall be taken by all concerned authorities.
- The action taken report, findings and suggestions from the Inspection Committee shall be submitted within a week of their visit to the concerned District Child Protection Units or H.P. State Child Protection Society as the case may be, for further action.
- On the submission of the report by the inspection committee within a week of the inspection, appropriate action shall be taken within a month by the District Child Protection Unit or H.P. State Child Protection Society and a compliance report shall be submitted to the State Government through Director, Women and Child Development.


